Meeting was called to order with a quorum at ~7:00 PM by Chairman Les Presmyk (LP). The Zoom Meeting ID: 665 521 6599.



I. COMMITTEE REPORTS.

- A. The January 5, 2023 Annual General Meeting Minutes provided with the announcement and link for this meeting were called for approval. Jim Armstrong moved that the minutes be accepted as submitted. Diann Knipp seconded. Genie Howell requested that a typo in the header be fixed. The motion, with Genie Howell's stipulation, passed without question, opposition or additional comment.
- B. Treasurer Report Bill Yedowitz (BY) presented on the Foundation's account balances and on investment re-alignment and closing one of the existing funds. He reported that he got the management authorizations on the Vanguard account updated to the FMF name and the current appropriate people authorized as signatory authorities.
- C. Collection Report:
- 1. BY: The Kerr family donated the final portion of the A.L./Richard Flagg collection to the FMF, primarily comprised of the A.L. Flagg thumbnail collection. A half dozen of the thumbnail boxes were reserved for the FMF collection along with a sphalerite specimen from the Sierrita Mine out of Richard Flagg's collection.
- 2. LP: was recently in California to pack and transport the U.S. collection of Robert Weaver. Les added that the U.S. minerals went to the UAMMNREM and the Arizona material went to the UAANGMM. Robert had eleven flats of miscellaneous specimens he graciously donated to the FMF after discussing the various possibilities for its disposition with LP.
- D. Flagg Gem & Mineral Show
- 1. John Weide (JW) stated as of the time of this meeting we will have about 150 dealers and 15 clubs for tomorrow's show.
- 2. LP noted that the exhibits this year are in the brand-new display cases purchased by FMF.
- 3. Jackie Peel asked about the Peralta Stones, which are on loan to the Superstitions Mountains Museum (SSM). BY confirmed that the SSM has documentation confirming that the Peralta Stones do, in fact, belong to the FMF.
- E. Symposium
- 1. Les informed the group that the 31st Annual Arizona Mineral Symposium will be held at the Gilbert Southeast Regional Library. The UAMMNREM is unavailable. The theme is "Celebrating the Field Collector, Part 2". There will be a half-dozen local dealers, including Michael Shannon with a 10,000 thumbnail and micromineral collection.

- J. UA Alfie Norville Museum (UAANGMM) Paul Harter reported that about 20% of the displays are fresh this year. Please check the museum website for information on the many upcoming events.
- K. Pinal Geology and Mineral Museum (PGMM) Dana Slaughter presented on an upcoming book give-away event on January 13. Books are free, please donate. A project is underway to install a new front door dedicated to the museum. This project is funded by the FMF. Dana thanked the FMF, for without our support, "...the Pinal Geology and Mineral Museum would not exist." Additional projects completed by PFMM with funding and support from the FMF's include: purchase and installation of new carpet and purchase of a wooden pull-out drawer specimen storage cabinet.
- L. Phoenix UArizona Mining, Mineral and Natural Resources Education Museum (UAMMNREM) LP presented on behalf of Catie Sandoval. LP stated that the \$12M funding is only about 40% of what is needed. The current budget looks to be at least \$30M. A new director has been hired and the announcement of the name is to be announced on January 22, when she starts in her position.
